- I, Gregory R. Ginn, hereby declare as follows:
- 1. I am the Plaintiff in the above-entitled case.
- I have personal knowledge of the facts stated herein and, if called as a witness, I could and would testify competently thereto.
- 3. I am a professional songwriter, musician, music publisher, and I am the sole shareholder of SST Records, Inc. I currently perform music using the mark "Black" a mark that I have used since late 1978.

- Flag," a mark that I have used since late 1978.

 4. I originally formed a band in 1976 in Hermosa Beach, California, so that I
- could perform a group of songs that I had written at that time. I initially formed the band with singer Keith Morris, and we called the band "Panic," a name that we used until late
- 1978. There were several bass players in Panic, and eventually Gary McDaniel (also
- known as Chuck Dukowski) joined (to fill in for a previous bass player, and for recording), and drummer Brian Migdol. Panic first performed in December 1977.
- 5. Soon thereafter, we learned that another band was using the name "Panic", and we changed the name of our band to BLACK FLAG in late 1978. We played our first paid show as BLACK FLAG on January 27, 1979 in Redondo Beach, California.
- 6. From the beginning of the band in 1976 to the present day, I have been the only original member of the band to remain a member of Black Flag. There have been many members of the band since 1979. In particular, Morris, the first singer, quit the band in late 1979, and formed his own band called The Circle Jerks. McDaniel, the bass player since 1977, ceased to perform with the band in 1983, and, as I note below, specifically agreed in 2007 to not use the name Black Flag (or any logo associated with it) in any fashion. After Morris left the band, he was replaced by singer Ron Reyes, who was later replaced by Dennis Cadena (also known as Dez Cadena), who ceased to be the singer in 1981 and who quit the band in 1983. After Cadena, singer Henry Garfield (also known as Henry Rollins) became the singer, and performed with Black Flag until June 1986. Garfield has never performed under that name since that time. There were also other bass players and other drummers, as discussed below.

In addition to my role as a performing musician, I am the sole shareholder 7. of a record company called SST Records, Inc., ("SST") which is currently incorporated in Texas. For the past 34 years, since the release of the first Black Flag recording in early 1979, SST has been the exclusive owner of all Black Flag recordings, and has been continuously and exclusively releasing and distributing phonorecords of Black Flag recordings, and, later through digital media. With the exception of McDaniel, who once was a partner in SST Records (but whose interests I purchased in October 1989), no other past or present member of Black Flag has ever been involved in the distribution or exploitation of Black Flag recordings, in any way. In addition to the distribution of phonorecords via national and regional distributors, SST also opened a retail store, called "SST Superstore," on Sunset Boulevard in West Hollywood, which was in business for several years in the mid-1990s. Attached hereto as "Exhibit A" are the front covers of the eighteen (18) official Black Flag releases on SST Records. According to Neilsen SoundScan, a well-known recording industry sales tracking system, the Black Flag catalogue has sold approximately 800,000 album units since the inception of SoundScan in 1991 (in addition to thousands of units sold in the 1980s), and hundreds of thousands of digital downloads of individual tracks.

- 8. In addition to the success and notoriety of the Black Flag's songs and recordings, the logo associated with Black Flag four uneven black bars simulating a waving black flag has become a well-known, iconic emblem. The BLACK FLAG name was suggested originally by my brother, artist Raymond Pettibon, who also designed the BLACK FLAG Logo. My brother also designed and created much of the artwork shown on the BLACK FLAG phonorecords.
- 9. The BLACK FLAG Logo became especially popular for use on clothing items and tattoos. SST manufactures and distributes a substantial number of clothing items with the logo, and, as discussed above, no other past or present member of Black Flag has been involved in sale or distribution of such merchandise items. Attached

hereto as "Exhibit B" is a set of photographs of some of the many merchandise items that SST Records manufactures and sells, including t-shirts, hats, sweatshirts, and baby clothes. The sale of these merchandise items is a major part of SST's business. For this business of selling phonorecords and merchandise, SST maintains a 16,000 square foot warehouse in Taylor, Texas.

- 10. With regard to the importance of the logo as an iconic symbol, this year a book was published called *Barred for Life*, which consists entirely of photographs, interviews, and stories about people who have gotten tattoos of the black bars on various parts of their bodies. Attached hereto as "Exhibit C" are several pages of that book.
- 11. In 2003, Black Flag played three reunion shows, two in Hollywood, California and one in Long Beach, California. Joining me for those shows were Cadena on vocals and a former drummer named Roberto Valverde, who had played with the band from 1979 to 1981. Black Flag also played in 2010 with singer Ron Reyes.
- 12. As I noted above, defendant McDaniel was a bass player in the band, joining in 1977 and leaving in 1983. After that time, he worked at SST and had an ownership interest. In October 1989, I purchased his interest. In 2006, however, McDaniel sued SST and me alleging that we had failed to account to him correctly for Black Flag royalties, and for other royalties for other musical groups in which he performed. McDaniel also claimed that he had an ownership interest in the Black Flag name and logo, and the revenues derived from the name and logo. That suit was settled in 2007, and in the settlement agreement, McDaniel agreed to never use, or profit from, the name Black Flag or any of its associated logos or trademarks. The pertinent portion of the settlement agreement is as follows:

"McDaniel confirms that he has no trademark rights in and to any of the trademarks or service marks exploited at any time in the past or present by SST, including, but not limited to, trademarks or service marks associated with Black Flag, SST.... and that McDaniel shall not be entitled to any money, royalties, or

 revenues from the exploitation of any of those trademarks or service marks, or their associated logos, designs, depictions, or any other graphical or typological use, on any articles sold to the public, via physical (such as t-shirts, hats, stickers, posters, and the like) or digital means, or used to promote SST or its catalogue of recordings."

- 13. Defendant Stevenson was also in Black Flag for approximately three years, from 1982 to 1985. To my knowledge, he has never claimed any right to use the name Black Flag or any of its associated marks or logos. Stevenson also sued me and SST in 2005, alleging royalty and accounting issues from the Black Flag recordings and other recordings owned by SST, but Stevenson never alleged that he has any ownership or any other right to use the Black Flag name, mark, or logo. The suit was settled in 2006.
- 14. According to the records of the United States Patent and Trademark Office (the "PTO"), on September 7, 2012, defendants Morris and Garfield filed two trademark applications, one for the mark in the "black bars" and one for the name Black Flag. On both applications, however, Morris and Garfield lied to the PTO about their use of the two marks, and submitted specimens of Black Flag record covers owned by SST. True and correct copies of those applications are attached hereto as "Exhibit D" and "Exhibit E."
- 15. In particular, Morris and Garfield told the PTO that they were using the marks on audio and video recordings, and had been doing so "At least as early as 10/1/1978." This is not true. To my knowledge, neither Morris nor Garfield have been using the name or mark on phonorecords at all, at *any* time, and the only entity that has *ever* used the name or mark on phonorecords has been SST Records. In their application, Morris and Garfield actually used photographs of SST's Black Flag releases, and misrepresented those releases as their own.
- 16. Further, Morris and Garfield told the PTO that they were using the Black Flag name and logo on "Hats; Pants; Shirts; Socks; Sweat shirts; T-shirts," and that they have done so since "at least as early as 12/1/1978." To my knowledge, this is not true

either, and Morris and Garfield have never made sales of BLCK FLAG merchandise any time in the past and have never had any ownership interest in SST.

- Morris and Garfield also lied to the PTO about their use of the mark and 17. logo for live performances. They declared under oath to the PTO that they had been using the mark for "Entertainment, namely, live performances by a musical band," since "at least as early as 12/1/1978," and that their use was continuous and uninterrupted to the present day. As noted above, Morris quit the band in 1980, and Garfield stopped performing with Black Flag in 1986. To my knowledge, before 2013, and after 1979, the only time Morris ever used the name Black Flag was at a one-time, unscheduled, impromptu appearance at the Santa Monica Civic Auditorium in late 2011.
- 18. In May 2013, defendants Morris, McDaniel, Cadena, Stevenson, and O'Reilly embarked upon a confusing tour and media campaign in which they use the marks and music associated with Black Flag, calling themselves "FLAG." Defendants are touring using my songs and the Black Flag logo, at the same time that I am touring using "BLACK FLAG." Attached as "Exhibit F" is a true and correct copy of the schedule of upcoming dates of performances of FLAG. These eleven (11) dates include one date in Los Angeles, August 24, 2013, at a large festival, and two more in California that same week. This course of conduct is confusing to the public, for the following reasons.
- 19. First, even though defendants are calling themselves "FLAG," they are also using the four black bars along with it. Attached hereto as "Exhibit G" are example of uses of the black bars by FLAG. I believe it is easy for the public to think that Black Flag would be performing at a certain venue, rather than FLAG. Second, I believe that defendants are in control of the Facebook page called "Black Flag," and that this page is partially controlled by defendant Morris with over 600,000 followers. A true and correct copy of the Facebook page called "Black Flag" is attached hereto as "Exhibit H." Defendants are utilizing this Facebook page to promote FLAG shows. Third, defendants are selling merchandise at their live shows (see Declaration of Jose Barraza, Exhibit A attached thereto) that is confusingly similar to actual Black Flag merchandise. Fourth, I

have personal experience with public confusion; many times during my touring activities, I have been asked if I was going to be at a certain show in the future, but these have turned out to be FLAG shows. For instance, in April 2013, I was repeatedly asked if I would "be in Las Vegas in May," or people said "I'll see you in Vegas in May," because FLAG was to perform at a large music festival called "Punk Rock Bowling."

- 20. Defendants control a second Facebook page called FLAG, which is also being used to promote their shows. A true and correct copy of the Facebook page called "Flag" is attached hereto as "Exhibit I." Defendants are utilizing this Facebook page to promote FLAG shows.
- 21. All of these acts are contributing to public confusion over the origin and identity of live performances of Black Flag's music. Attached hereto as "Exhibit J" is the first two pages of a Google search using the words "BLACK FLAG TOUR," which yields 20 different items. A number of those news items are also attached to Exhibit J. In eleven of those items, there is either confusion over the two competing tours, or in which the article or item seeks to "explain" the reason why there are two competing bands, both using my songs, a similar name, and the same logo.
- 22. This confusion is due to defendants' actions. They chose to use the name FLAG, and to play songs made popular by Black Flag, and to use either a logo that is very similar to the original logo, or else is identical to the original logo.
- 23. All five defendants need to be enjoined from further acts of unfairly competing with Black Flag. Further, the trademark application of Garfield and Morris is untruthful and should be denied, and trademark for the "four bars" cancelled.

I declare under penalty of perjury under the laws of the United States that the foregoing is true and correct.
